DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Shake well before using.

Fleas: Use ADAMS™ Home Flea & Tick Spray in homes, garages, attics, apartments, and hotels. One bottle will treat a surface area equivalent to approximately three 10' x 10' rooms. A fine spray applied uniformly is all that is necessary to kill fleas. Avoid wetting furniture and carpeting. Remove birds and cover aquariums before spraying. For maximum effectiveness, treat entire carpeted area. Treat carpets, rugs, drapes, and all surfaces of upholstered furniture. Old pet bedding should be removed and replaced with clean fresh bedding after treatment of pet area. Retreat as necessary. Leave treated areas and do not return for at least 1 hour.

Avoid contamination of food and foodstuffs. Do not use in edible product areas of food processing plants, restaurants, or other areas where food is commercially prepared, processed, stored, or served.

To kill ticks, roaches, silverfish, earwigs, and ants in the environment, apply directly to pests.
